

## INTERNATIONAL IRREGULAR MIGRATION SYMPOSIUM

### CALL FOR DECLARATION

*"International Irregular Migration Symposium"* will be organized by the Institute of Security Sciences of the Gendarmerie and Coast Guard Academy (GCGA) between the 8th and 9th of May, 2024. The aim of the symposium is to examine the causes, measures, possible consequences, and management of irregular migration movements that directly affect the field of duty of the Gendarmerie and Coast Guard organizations, which have a leading role in establishing security and public order in our country, from an academic perspective. The aim is to ensure that ideas are shared among scientists who conduct research in the field of study in question and pioneering interdisciplinary studies.

The symposium is available for participation to all academicians and researchers that are occupied with the field in question across Türkiye, and the world. The International Symposium on Irregular Migration will be held at GCGA Beytepe Campus (face-to-face), and participants from abroad will be able to make their presentations online (via video conference) or offline (via video recording submission) if they wish.

The languages of the symposium will be Turkish and English, with simultaneous translation provided from both languages. Participation in the symposium is free of charge. The symposium will be held within the scope of the following topics:

## **APPLICATION AND PARTICIPATION CONDITIONS**

- Abstracts prepared within the framework of the symposium topics will be sent to [jsgagoc2023@gmail.com](mailto:jsgagoc2023@gmail.com) in "\*.doc or \*.docx" format by adding them to the **Abstract Form of the Declaration** until January 19, 2024.
- The article and research submitted to the symposium must not have been presented or published anywhere before.
- The symposium is available for the participation of all academicians, postgraduate students, researchers, and forensic science experts from Türkiye and abroad. The symposium language will be Turkish and English, and simultaneous translation will be provided.
- Abstracts should be between **400** and **750** words and include an abstract, introduction, research method, methodology, results, and keywords. They should be written in Turkish and English. There is no obligation for full text to be written in English.
- The abstract and the full text must be prepared in accordance with the spelling rules. Abstracts and papers that do not comply with the spelling rules will not be evaluated.
- Extended abstracts will be evaluated via the method "blind refereeing", in which criteria such as compliance with the symposium topics, scientific conditions, and originality of the work are evaluated.
- Each paper in the program will be allocated a total of 20 minutes: 15 minutes for presentation and 5 minutes for discussion.
- Abstracts will be evaluated by the members of the Scientific Committee based on their conformity with the symposium topics, scientific conditions, and originality.
- The book containing the abstracts of the accepted papers will be prepared in electronic format and published on the symposium page.
- A participant who submits the abstract and full text of the paper to the organizing committee or sends it to the symposium e-mail address is deemed to have given permission to print the abstract and full text of the paper.
- Participants will not be charged.

## **FULL TEXT SUBMISSION:**

- Submission of full texts is not mandatory; it depends on the preference of the authors.
- The full texts presented by the authors at the symposium and evaluated and accepted as a result of the "blind refereeing" system will be published as a national article in the Symposium Special Issue of the JSGA Journal of Security Sciences or as a book chapter in an international scientific book in 2024 upon the request of the authors. Authors should indicate which publication option they prefer when submitting their full texts.
- Full texts will not be evaluated during the symposium of authors whose papers are not presented.
- The full texts prepared by the authors should be sent to [jsgagoc2023@gmail.com](mailto:jsgagoc2023@gmail.com) as an attached file in "\*.doc or \*.docx" format until **June 21, 2024**, in accordance with the publication rules of the Gendarmerie and Coast Guard Academy Journal of Security Sciences [<http://www.jsga.edu.tr/gbd/makale-yazim-esaslari>].
